Owners or owner's agent is responsible for errors on entry forms. Entry fee(s) and PayPal service fees WILL NOT be refunded in the event of such error, cancellations received after the closing date, or if a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by the Show Committee.

Entry fee(s) and/or PayPal fees WILL NOT be refunded if the dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee. No entry fee(s) will be returned if the Trial cannot open or be completed by reason of civil disturbance, fire, flood, public emergency, act of a public enemy, act of God, or any other cause beyond the control of the organizing committee.

Transfers in Rally and Obedience will be allowed as specified in Chapter 1, Section 16a of the Obedience Regulations and Chapter 1, Section 15 of the Rally Regulations. The request for transfer must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of Saturday's or Sunday's trials.

FLOOR SPACE IS LIMITED. NO X-PENS WILL BE ALLOWED INSIDE THE BUILDING AND CRATES MUST BE STACKED. Unentered dogs are NOT allowed on the show grounds. All dogs must be at least six months of age on the day of the trial. Bring your own chair.

If a bitch comes into season after entries close, but before the start of Saturday's show and owner notifies the show secretary (in writing) no later than 30 minutes before the start of the first class the day of the show entries will be refunded in full, but PayPal fee will not be refunded. No refunds made if a bitch come into season after the start of the first show.

If an entry is sent by any express mail carrier, please check the NO SIGNATURE REQUIRED box.

Checks that have been returned due to insufficient funds do not constitute a valid entry and will have a \$30 service charge assessed. Changes, additions, or corrections to entry forms must be received in writing or emailed prior to close of entries. Telephone calls/messages will not be accepted.

To ensure the safety of the dogs, exhibitors and spectators, unless showing in their ring runs, dog must be crated.

The AKC has charged Trial giving clubs the responsibility to enforce the Rules and Regulations forbidding drilling and/or unacceptable training on the trial grounds. Chapter 2, Section 20 - The use of spiked or other special training collars WILL NOT be permitted on the trial site. DRILLING, INTENSIVE OR ABUSIVE TRAINING ON THE SHOW GROUNDS WILL NOT BE TOLERATED. These requirements should not be interpreted as preventing handlers from moving normally about the grounds or premises or from warming up their dogs provided the dog is on a leash being held by the handler. Warm-ups should be performed as far from the rings as is reasonably possible and must not be disruptive to any dog or person. Physical or verbal disciplining of a dog will not be permitted, except to a reasonable extent in case of an attack on either a dog or a person.

Top Dog Training Center charges a fouling fee should your dog pee or poop in or near ring area. The charge ranges from \$5 to \$25.

#### COVID-19

SADTC will abide by any Covid mandates in place by county or state authorities at time of trial. At this time, masks are optional, but be aware that if conditions change, we reserve the right to make masks mandatory.

Should it become necessary, we encourage you to practice with your dog with a mask so she is used to working with you with a mask and so that you learn to give commands loud enough for your dog to hear.

We will have a hospitality table, if conditions permit. There is *no drinking water available*, but SADTC will sell water in bottles.

(Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)

5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.

## **Trial Fees**

Submitting the correct amount for the trial seems to confuse a lot of people. In an effort to clarify and make the entry fees easier to understand, please read the following

Each trial (Saturday Morning, Saturday Afternoon, and Sunday) each start with the \$32 fee. If you enter rally and obedience, each is considered a separate trial. So you always start with the *\$32 fee for your first entry for each trial*. If you enter another class in rally or obedience, you add \$30. If you enter a third class, you add another \$30.

If you only enter 1 class for a trial, your cost would be \$32. If you enter all 3 trials, your cost would be \$32 X3= \$96 if you paid by check; if you use PayPal, you add \$4, so your cost is \$100.

#### For example, in Rally Saturday morning trial, your fees would be as follows:

Masters Excellent Advanced	\$32 \$30 \$30	This would be for one trial. If you enter all three trials in Rally, you would send a check for $92X3 = 276$ ; If you paid with PayPal,
TOTAL	\$92	your cost would be \$276+ \$4 = \$280


